COURSE DESCRIPTION

In this course will try to answer the question: IS GOD NECESSARY FOR MORALITY? CAN THERE BE MORALITY WITHOUT GOD? Some thinkers argue that there is an objective morality only if there is a God, or, equivalently, that without God there is not morality. This view has come be known in the literature as Divine Command. A variant of that ethics is called Prophetic Ethics, a view that has come into prominence since the 1960s. Alternatively, some thinkers believe one can be moral without or whether there is a God or not. One such view is Virtue Ethics, another is Natural Law Ethics, and yet another, evolutionary ethics, among others.

COURSE REQUIREMENTS

- 1. Class Presentation (2-page, 12 pt. font) delivered orally based on the assigned reading for the week (10% of grade).
- 2. Two short essays (3-4 pages) on topics distributed by the instructor, based on the assigned readings (50% of grade).
- 3. Four (4) Group Discussions on topics based on the readings (40% of grade).
